City of Dreams Becomes the First Hotel and Integrated Resort in Macau Awarded the OHSAS 18001 Occupational Health and Safety Management Certification

Effort to provide the best possible and safest working environment recognized

MACAU – Thursday, November 12, 2015: Melco Crown Entertainment Limited (Nasdaq: MPEL) (“Melco Crown Entertainment”, “MCE” or the “Company”), a developer, owner and operator of gaming and entertainment resort facilities in Asia, is proud to announce its flagship integrated resort, City of Dreams, is the first hotel and integrated resort in Macau awarded the OHSAS 18001 Occupational Health and Safety Management Certification by the world-wide international certification body – British Standards Institute (BSI Hong Kong). This is another proud milestone for the Company’s steadfast effort in the adoption of the internationally recognized management standard. City of Dreams was also the first in Macau to have received the HACCP food safety certification in 2011 and the ISO 14064 Greenhouse Gas (GHG) Emissions Inventories and Verification in 2014. And Melco Crown Entertainment is the first resort-hotel company in Macau to receive the ISO14001:2004 Environmental Management Certification and Indoor Environmental Quality Certificate in 2012.

“I wish to dedicate this astounding success to all the team members who have put tremendous effort in making all these possible. It took colleagues from 16 departments seven months of hard work from documentation, trainings to certification audit,” said **Mr. David MacKay, Senior Vice President of Asset Protection from Melco Crown Entertainment**, “This achievement demonstrates Melco Crown Entertainment’s care for our employees. Providing our employees with the best possible and safest working environment and conditions has always been the Company’s utmost priority. This principle has driven us continuously to push our limits for excellence and being a pioneer in occupational health and safety.”

In his remarks at the ceremony, **Mr. Coleman Tse, Sales and Marketing Director of BSI Hong Kong** said, “Melco Crown Entertainment’s City of Dreams has been instrumental in the promotion of the overall occupational health and safety culture in the hotel and integrated resort industry in Macau. We believe that City of Dreams’ investment in occupational health and safety will assure a safe environment for both its employees and customers.”

In order to maintain the highest standards of health and safety, and to ensure compliance with international standards, a total of 14 employees from various departments of Melco Crown Entertainment were specially trained and qualified as OHSAS 18001 Internal Auditors. They will be playing a crucial role in monitoring and implementing safety management system in the Company.

Melco Crown Entertainment was the first gaming concession in Macau to have both its properties, Altira Macau and City of Dreams, signed the Occupational Safety and Health charter with the Macau Labor Affairs Bureau in 2010 and 2012 respectively. Established in 2011, Melco Crown Entertainment's Occupational Safety and Health Committee aims to provide the Company's operational departments with solid support in enhancing safety and welfare of its employees.

With the successful implementation of OSH measures and investments on staff protection, Melco Crown Entertainment successfully reduced the number of accidents by 26% from 2012 to 2014. Other than innovative measures to enhance OSH, Melco Crown Entertainment also offers its employees various training courses at the Company's own Learning Academy. As of September 2015, over 5,586 employees attended these OSH training courses. With the joint efforts of the OSH Committee and the effective training program, an impressive reduction of 21% in the rate of staff time lost due to accidental injury was recorded in 2014.
