**Melco supports recognition program celebrating achievements of teachers  
from Guizhou's Congjiang County**

Sponsoring the Macao SAR Government's efforts for poverty alleviation

**Macau, Monday, September 9, 2019** — Melco Resorts & Entertainment is pleased to offer its support for the *Rural Congjiang County Outstanding Teachers Reward Program* to recognize and celebrate the achievements of teachers from rural Congjiang in Guizhou Province, China. The initiative is part of the nine collective agreements from the Liaison Office of the Central People's Government in the Macao SAR (the "Liaison Office") involving the Macao Government and the People's Government of Guizhou Province for targeted poverty alleviation. Upon the opening of City of Dreams Mediterranean, the Company will operate the City of Dreams Mediterranean integrated resort and continue to operate the four satellite casinos. The Company also holds equity interests in Crown Resorts Limited ("Crown"), a company listed on the Australian Securities Exchange and which operates two of Australia's leading integrated resorts, Crown Melbourne Entertainment Complex and Crown Perth Entertainment Complex. In the United Kingdom, Crown operates Crown Aspinalls, a high-end licensed casino in London. Crown's development projects include the Crown Sydney Hotel Resort at Barangaroo on Sydney Harbour. Crown also holds equity interests in the Aspers Group and Nobu and has interests in various digital businesses.
