To provide a better understanding of Melco's uniform requirements and standards, a tour of City of Dreams' Wardrobe Facilities catering to approximately 8,000 employees was also held for SME representatives attending the event. Attendees were shown samples of Melco's existing uniforms, and the event wrapped up with a business matching session offering SMEs the chance to register onsite as a Melco vendor.

### About the 'Melco Environmental Services Team Uniform Design Competition'

The competition aims to create new uniforms for the Company's Environmental Services team of nearly 400 employees working in various roles at Melco's Macau integrated resort properties. Judging criteria will include alignment with the Melco brand, aesthetics, design concept, practicality, comfort and material selection. Open for application from now until early January 2020 to all Macau residents aged 18 and above, the competition encourages participation from persons working in the fashion industry and/or those with their own design brand, uniform retailers, and garment manufacturers. Three stages to the competition include the initial selection of the top ten entries; followed by the selection of the top three entries to be manufactured into actual sample garments; and the selection of the winner, 1st Runner up and 2nd Runner up as voted by Melco's employees. 

Its business also includes the Mocha Clubs (www.mochaclubs.com), which comprise the largest non-casino based operations of electronic gaming machines in Macau. The Company also majority owns and operates Studio City (www.studiocity-macau.com), a cinematically-themed integrated entertainment, retail and gaming resort in Cotai, Macau. In the Philippines, a Philippine subsidiary of the Company currently operates and manages City of Dreams Manila (www.cityofdreamsmanila.com), a casino, hotel, retail and entertainment integrated resort in the Entertainment City complex in Manila. In Europe, the Company is currently developing the City of Dreams Mediterranean integrated destination resort project (www.cityofdreamsmed.com.cy) in the Republic of Cyprus, which is scheduled to open in 2021 and expected to be the largest premier integrated destination resort in Europe. The Company is currently operating a temporary casino, Cyprus Casinos, the first casino in the Republic of Cyprus and three satellite casinos with a fourth satellite casino scheduled to open by the end of 2019. Upon the opening of City of Dreams Mediterranean, the Company will operate the City of Dreams Mediterranean integrated resort and continue to operate the four satellite casinos. The Company also holds equity interests in Crown Resorts Limited ("Crown"), a company listed on the Australian Securities Exchange and which operates two of Australia's leading integrated resorts, Crown Melbourne Entertainment Complex and Crown Perth Entertainment Complex. In the United Kingdom, Crown operates Crown Aspinalls, a high-end licensed casino in London. Crown's development projects include the Crown Sydney Hotel Resort at Barangaroo on Sydney Harbour. Crown also holds equity interests in the Aspers Group and Nobu and has interests in various digital businesses. For more information about the Company, please visit www.melcoresorts.com.
