Melco Chairman & CEO visits Zhuhai with team of senior executives

Part of 'Splendors of China' initiative, visit is the first in a series to develop in-depth understanding of the Greater Bay Area for management team

Macau, Tuesday, October 8, 2019 – Melco Resorts & Entertainment Chairman & Chief Executive Officer Mr. Lawrence Ho recently paid a visit to the city of Zhuhai with a team of the company's senior executives as part of the Melco initiative 'Splendors of China'. The visit is the first in a series to enhance and strengthen Melco management team's understanding of the Greater Bay Area, with further trips being planned to Shenzhen and Guangzhou in the coming months.

Mr. Lawrence Ho and the team of twelve senior executives from Melco met with representatives from the Liaison Office of the Central People's Government in the Macao SAR (Liaison Office), including Mr. Zuo Xianghua, Director of Economic Affairs Department; and Mr. Yang Yi, Deputy Director of Economic Affairs Department, as well as Zhuhai officials including Ms. Zou Hua, Director of Zhuhai Municipal Affairs Bureau of Taiwan, Hong Kong and Macao; Mr. Huang Yuan Peng; Deputy Director of Zhuhai Municipal Affairs Bureau of Taiwan, Hong Kong and Macao; Mr. Xie Liang, Director of Zhuhai Foreign Investment Service Center; and Ms. Su Cuizhu, Divison Chief of Municipal Affairs Bureau of Taiwan, Hong Kong and Macao; and was introduced to Zhuhai's unique positioning within the Greater Bay Area and its relationship with Macau.

The Melco team visited the Hengqin integrated tourism and entertainment project Novotown, visiting Lionsgate Entertainment World and National Geographic Ultimate Explorer within the complex. The team also visited Gree Electric Appliances' headquarters in Zhuhai, visiting the company's display hall, production line and laboratory.

Mr. Lawrence Ho, Chairman & Chief Executive Officer of Melco Resorts & Entertainment, said, "As one of the largest corporations in Macau, visiting our neighboring city of Zhuhai to learn about its impressive developments over the past few years, as well as the city's positioning within the Greater Bay Area has been inspirational. We are grateful for the Liaison Office's support to enable this invaluable opportunity, and we look forward to contributing further towards the Greater Bay Area's developments with Melco's world-class hospitality and entertainment offerings."

'Splendors of China' is a Melco-developed learning program about China's cultural heritage, history, and modernization which helps colleagues better understand and deliver Melco's service promise to Mainland Chinese customers who account for the majority of the Company's clientele. Recent



initiatives have included seminars on Chinese history and *Xi Jinping Thought* taught by an eminent professor from Tsinghua University, national education study trips, and various exhibition visits.



The Company also majority owns and operates Studio City (www.studiocity-macau.com), a cinematically-themed integrated entertainment, retail and gaming resort in Cotai, Macau. In the Philippines, a Philippine subsidiary of the Company currently operates and manages City of Dreams Manila (www.cityofdreamsmanila.com), a casino, hotel, retail and entertainment integrated resort in the Entertainment City complex in Manila. In Europe, the Company is currently developing the City of Dreams Mediterranean integrated destination resort project (www.cityofdreamsmed.com.cy) in the Republic of Cyprus, which is scheduled to open in 2021 and expected to be the largest premier integrated destination resort in Europe. The Company is currently operating a temporary casino, Cyprus Casinos, the first casino in the Republic of Cyprus and three satellite casinos with a fourth satellite casino scheduled to open by the end of 2019. Upon the opening of City of Dreams Mediterranean, the Company will operate the City of Dreams Mediterranean integrated resort and continue to operate the four satellite casinos. The Company also holds equity interests in Crown Resorts Limited ("Crown"), a company listed on the Australian Securities Exchange and which operates two of Australia's leading integrated resorts, Crown Melbourne Entertainment Complex and Crown Perth Entertainment Complex. In the United Kingdom, Crown operates Crown Aspinalls, a high-end licensed casino in London. Crown's development projects include the Crown Sydney Hotel Resort at Barangaroo on Sydney Harbour. Crown also holds equity interests in the Aspers Group and Nobu and has interests in various digital businesses. For more information about the Company, please visit www.melco-resorts.com.
