4. how Macau can give full play to its advantages to deepen cooperation with cities in the Greater Bay Area such as Hengqin for diversified development.

Furthermore, the Forum's general themes included guidance for Macau's development as provided by the Premier's government work report and ways to enhance communications between CPPCC and NPC representatives and Macau citizens for public opinion and participation in the deliberation and administration of state affairs.
