Melco makes another wave of support to the community

- Donating MOP 3 million to *Women's General Association of Macau* for the purchase of surgical face masks and providing allowance scheme for families impacted by the Coronavirus

Macau, Sunday, February 23, 2020 – In light of the health concerns related to the outbreak of COVID-19, Melco Resorts & Entertainment is collaborating with community partners *Macao Daily News* and *Women's General Association of Macau* to drive public awareness and wellbeing for the local community.

Melco is donating MOP 3 million for the purchase of surgical face masks to its long-term community partner, *Women's General Association of Macau*, with the aim to help reduce risk of infection. The donation will also provide for an allowance scheme to help families impacted by the new strain of Coronavirus, in particular single mothers and those with children with special needs.

Furthermore, Melco is supporting *Macao Daily News* on an extensive online video promoting personal and public hygiene and wellness. The series, titled 'Healthy Macao: Essential Tips for Combatting Illness', covers topical information on issues such as ways to identify symptoms of COVID-19, how to wear tie-on surgical masks safely and effectively, best bathroom hygiene practices, choosing household disinfectants, and stretches for maintaining physical health and wellbeing.

Mr. Lawrence Ho, Chairman and Chief Executive Officer of Melco, said, "Melco is fully committed to supporting the local community through these particularly difficult times. Its business also includes the Mocha Clubs (www.mochaclubs.com), which comprise the largest non-casino based operations of electronic gaming machines in Macau. The Company also majority owns and operates Studio City (www.studiocity-macau.com), a cinematically-themed integrated entertainment, retail and gaming resort in Cotai, Macau. In the Philippines, a Philippine subsidiary of the Company currently operates and manages City of Dreams Manila (www.cityofdreamsmanila.com), a casino, hotel, retail and entertainment integrated resort in the Entertainment City complex in Manila. In Europe, the Company is currently developing City of Dreams Mediterranean (www.cityofdreamsmed.com.cy) in the Republic of Cyprus, which is scheduled to open in 2021 and expected to be the largest and premier integrated destination resort in Europe. The Company is currently operating a temporary casino, the first casino in the Republic of Cyprus, and three satellite casinos with a fourth satellite casino scheduled to open in the coming months (“Cyprus Casinos”). Upon the opening of City of Dreams Mediterranean, the Company will also continue to operate the four satellite casinos while operation of the temporary casino will cease. The Company also holds equity interests in Crown Resorts Limited (“Crown”), a company listed on the Australian Securities Exchange and which operates two of Australia’s leading integrated resorts, Crown Melbourne Entertainment Complex and Crown Perth Entertainment Complex. In the United Kingdom, Crown operates Crown Aspinalls, a high-end licensed casino in London. Crown’s development projects include the Crown Sydney Hotel Resort at Barangaroo on Sydney Harbour.
