## **Melco continues to support the Macau SAR Government's Congjiang County poverty alleviation efforts**

**Macau, Tuesday, June 9, 2020** – Melco Resorts & Entertainment continues to support the Macau SAR Government's poverty alleviation efforts for Guizhou Province's Congjiang County. Further to supporting the [Rural Congjiang County Outstanding Teachers Reward Program](#) as part of the nine collective agreements from the Liaison Office of the Central People's Government in the Macau SAR (the "Liaison Office") involving the Macao Government and the People's Government of Guizhou Province, Melco announces the purchase of 500 gift packs of agricultural specialties from Congjiang, comprising dried mushrooms, dried edible fungus, oil chili, and camellia oil to support the county's resumption of production.
