Melco colleagues visit National Security Education Exhibition as part of Splendors of China program

Enriching colleagues' understanding of the Motherland's National Security developments

Macau, Friday, April 16, 2021 – As part of Melco Resorts & Entertainment's *Splendors of China* learning program, 50 colleagues from the Melco management team today visited the 'National Security Education Exhibition' located at the headquarters of the Macau Forum for Cooperation between China and the Portuguese-Speaking Countries. The purpose of the visit is to enrich Melco colleagues' understanding of the Motherland's National Security developments and its implementation within the Macau SAR. Further Melco group visits are planned, and a total of approximately 300 Melco colleagues are expected to tour the exhibition.
