Melco Scoops Multiple Awards in the 2016 DSAL Catering Industry OSH Scheme Recognizing its Continued Commitment to Excellence in Catering OSH

Tenmasa at Altira Macau also won the Excellence Award in the Hotel Restaurants (Group C) category.
